TERMS AND CONDITIONS

1 Limits on the Residential Energy Efficient Pool Pump Reward

- 1.1 Agreements may be made for only one Residential Energy Efficient Pool Pump Reward per Eligible Property.
- 1.2 Agreements may be made by either the owner or the tenant of an Eligible Property (provided that the Agreement is made by the electricity account holder), with only one Residential Energy Efficient Pool Pump Reward to the value of \$250 per Eligible Property Application able to be submitted by the Applicant.
- 1.3 Agreements must be received by ENERGEX by **5pm, Friday 18 May 2012**.
- 1.4 Agreement Forms must relate to a pool pump that is Minimum 5-Star Energy Efficient and which was purchased by the Applicant and installed at the Eligible Property between 1 September 2011 and 18 May 2012 (inclusive).
- 1.5 Spas and Spa pumps are not eligible.
- 1.6 The Residential Energy Efficient Pool Pump Reward is not available as a point of sale discount or payable directly to service providers or retailers.

2 Eligibility for the Energy Efficient Pool Pump Reward

By signing this Agreement, the Applicant confirms they:

- are aged 18 years or older;
- are the electricity account holder at the Eligible Property;
- have attached a completed Residential Registered Owner Approval Form with this Agreement, if the Applicant is the tenant of the Eligible Property;
- attached a completed Agreement Form that has been signed and dated by the Applicant;
- attached a copy of proof of purchase and installation of the Minimum 5-Star Energy Efficient Pool Pump;
- have not applied for and/or received any pool pump or off-peak pool reward from any other ENERGEX initiative.

The decision whether a Minimum 5-Star Energy Efficient Pool Pump Reward is payable will be made by ENERGEX in its absolute discretion following receipt of a correctly completed Agreement.

3 Payment of the Energy Efficient Pool Pump Reward

Where an Energy Efficient Pool Pump Reward is payable, ENERGEX will pay by way of a \$250 EFTPOS gift card directly to the Applicant at the address as nominated on the Agreement Form.

4 General

The Applicant agrees that:

- (a) ENERGEX may reject any Agreement Form that is incomplete, not executed or not accompanied by the necessary documents (copy of proof of purchase and/or installation) or which ENERGEX has reason to believe is inaccurate or fraudulent;
- (b) ENERGEX may make enquiries or audit as to any Agreement [including checking with retail outlets] to determine whether the Residential Energy Efficient Pool Pump Reward is payable;
- (c) ENERGEX may require repayment of the Residential Energy Efficient Pool Pump Reward if any information contained in the Agreement Form is not true and correct, including if the Agreement Form has not provided a copy of proof of purchase and installation with the Agreement Form or provided information as to the company from which the product was purchased.
- (d) ENERGEX shall not be responsible for, and the Applicant releases ENERGEX to the full extent permitted by law for liability in respect of any warranty or other issues relating to the energy efficient pool pump for the purposes of submitting this Agreement, including but not limited to all costs incurred by the Applicant in connection with this Agreement.

5 Privacy Notice

ENERGEX is collecting, using and disclosing your personal information for the purpose of conducting this Initiative and advising you of ways to save energy through its energy conservation and demand management programs.

You consent to the use of your personal information as set out in the Agreement for the purposes of this Initiative and for similar initiatives that may be conducted by ENERGEX, the Queensland Government and/or your local government council.

If you do not provide your personal details, you may, at ENERGEX's discretion, not be eligible to participate in the Initiative to receive an Energy Efficient Pool Pump Reward.

Definitions

Agreement means these Terms and Conditions and accompanying Agreement Form.

Applicant or **You** means the electricity account holder at an Eligible Property that is making the application for a Residential Energy Efficient Pool Pump Reward.

Eligible Property means any residential property within the ENERGEX distribution network area in South East Queensland that has a swimming pool where a Minimum 5-Star Energy Efficient Pool Pump has been installed between 01 September 2011 and 18 May 2012 (inclusive).

Initiative means ENERGEX's Energy Efficient Pool Pump program.

Minimum 5-Star Energy Efficient refers to Minimum Energy Performance Standards (MEPS) Regulations in Australia. Pool filtration equipment will be eligible for this reward if it meets a 5-Star or better MEPS rating. Further details on MEPS can be accessed online at <http://www.energyrating.gov.au/meps1.html>

Pool Pump includes any fixed speed, variable speed, variable frequency, multi-speed pool pump or after market drive used to provide filtration or sanitation for a residential pool.

Residential Registered Owner Approval Form means the form accompanying this Agreement Form (where the Applicant is the tenant of the Eligible Property), signed by the owner of the Eligible Property authorising the installation of the Minimum 5-Star Energy Efficient Pool Pump at the Eligible Property.
