The Temporary Closure of footpath, shoulder edge and part of any road or street within the Ipswich City Council local road area for the purposes of undertaking maintenance works on power poles on behalf of Energy Queensland Ltd in the area (per Ipswich City Council Permit 250417-000391).

From:

TUESDAY 1st July, 2025 to TUESDAY 20th June, 2026 between 7:00am and 5:00pm on a local street, between 9:00am and 4:00pm on a major arterial road Monday to Friday, between 9:00am and 2:00pm withing 200m of a school zone on a school day along with between 8:00am and 5:00pm Weekends excluding public holidays ONLY. TRAFFIC DIVERSION CANNOT BE PLACED ON THE ROAD UNTIL THE ABOVE LISTED TIMES AND MUST BE REMOVED BY THE ABOVE LISTED TIMES.

## **CONDITIONS:-**

- 1. This permit is to be held at all times and produced on demand to a Police Officer.
- 2. All signs, lights and safety cones to comply with and to be positioned and erected as per the *Manual of Uniform Traffic Control Devices*.
- 3. The applicant is responsible to ensure that any excavations, roadworks, barriers, signs, materials or objects of any nature associated with the project development are sufficiently light or made obvious to any pedestrian or motorist to prevent risk of injury or death to any person.
- 4. Safety cones or barricading is to be positioned around work area.
- 5. Pedestrian access to be restricted from work site at all times.
- 6. During the hours of darkness, barricading shall be positioned around work area with sufficient flashing amber light at regular intervals to give adequate warning to pedestrian and vehicular traffic to prevent collision with barricading or excavation materials or trenches.
- 7. All signs and material to be removed from roadway and roadway left in good condition at completion of work.
- 8. All council and/or Main Roads Department conditions to be complied with. [ICC 250417-000391].
- 9. Alternative safe passage to be made for pedestrians, cyclists and motorists.
- 10. Entry and egress are to be maintained for residential and business premises AT ALL TIMES.
- 11. Minimum of One [1] Qualified Traffic Controller and [1] Traffic Control Vehicle at each site to be on duty during the hours of site operation to assist motorists and pedestrians around work site as required.
- 12. All care to be taken to avoid incidents [2 traffic controllers to be on duty during stop / go and two-lane closures; REFER TO IPSWICH COUNCIL CERTIFICATE 250417-000391 FOR ALL CLOSURES, TIMES and CONDITIONS; MUST HAVE ICC CERTIFICATE 250417-000391 ON SITE AT ALL TIMES].
