## **Energex Field Services General Terms and Conditions**

- 
- If this offer is not accepted within sixty (60) days from the date of this quotation it may lapse and cost estimates may be reviewed and amended.
- 
- The completion date may be extended where weather conditions delay progress on this project or other preceding projects.
- 
- The customer is responsible for providing access to the site to allow commencement of the works by the programmed start date.
- 
- If the customer is responsible for a certain part of the project, and this part is not completed on time, or not to the required standard, causing delays to the project, Energex will charge a rescheduling fee.
- 
- The customer is responsible for advising if any environmental restrictions apply to the project area or access to it (e.g. declared plants, contaminated sites).
- 
- No provision is included for installing or providing for installation of other service provider assets.
- 
- Open cutting or under-boring of roads and driveways is included only at locations specified. Any additional locations will be at the customer cost.
- 
- Additional visits to the project due to failure of the customer or other parties to meet programmed or agreed progress targets are not included and costs incurred as a result will be charged to the customer.
- 
- The customer will be responsible for the lost on-site productivity time caused by the customer or other parties working on the project.
- 
- Scrap or surplus material that is the property of the customer will be delivered to the site nominated by the customer in the project specification during the project or at the time of practical completion. Any dumping charges for the disposal of surplus material or spoil will be at the customer's expense unless specified in the quotation.
- 
- The project completion date will be negotiated on receipt of the customer's Acceptance of this Quotation and will be subject to the availability of materials, services or responsibilities to be provided by the customer.
- 
- Hard excavation costs will apply where hole depths cannot be achieved using a standard Energex borer lifter or trenching cannot reasonably be done using a Case 580 or equivalent backhoe.
- 
- The customer is responsible for providing all necessary survey markings required for project completion unless otherwise indicated in the quotation.
- 
- The copyright to any designs remains the property of Energex Field Services.
- 
- Additional earthing charges will apply where the necessary earth reading cannot be obtained by installing one (1) standard earth electrode in soil.
- 
- Energex Field Services will make good by repair or replacement any defects which, in our opinion, are the result of faulty materials or workmanship supplied by Energex Field Services under this quotation, and are reported to Energex Field Services within twelve (12) months of practical completion of these works.

## **Additional Terms and Conditions for Scoping and/or Escorting High Loads**

- 
- Energex will be operating under the directions of police officers (if provided as part of the escort). This quote does not include costs associated with the Queensland Police Service (QPS).
- 
- Should a member of the police issue a lawful direction to stop or redirect the load, and this act delay or extend the job, all additional costs will be treated as a variance.
- 
- If the load height is greater than that shown on this application, the load will not be moved and any additional costs will be treated as a variance.
- 
- Any damage to Energex assets caused by the load will be treated as a variance.
- 
- Energex reserves the right to stop the high load movement and recall staff to attend to Emergencies. Energex's liability in this instance shall be limited to rescheduling of the high load movement at a later date.
