

**NOTICE OF AMENDMENT OF LAND DESIGNATED FOR
COMMUNITY INFRASTRUCTURE MADE UNDER THE
SUSTAINABLE PLANNING ACT 2009**

**Amendment to a designation of land for community infrastructure
has been made**

I, STEPHEN ROBERTSON MP, Minister for Energy and Water Utilities, give notice that under the *Sustainable Planning Act 2009*, Chapter 5, I have made a minor amendment to an earlier designation of land for community infrastructure by removing two easements and two waterway crossings from the earlier designation.

The earlier designation was notified in the Queensland Government Gazette on 1 April 2011 as land on which ENERGEX Limited (ENERGEX) proposes to build the SunCoast Power Project.

Reason for amendment

The reason for the amendment is that these areas of land are not required for the SunCoast Power Project but were inadvertently included in the earlier designation notice.
