CONDITIONS

- Approvals received from the relevant local government authority, either TRC, LVRC, SDRC, and/or DTMR for 1. any works being carried out are required to be emailed, by the applicant, to QPS via Permits.SpecialsToowoomba@police.qld.gov.au at least 5 days prior to commencing any work. These emails are to include the actual start date of the works;
- The Qld Fire and Rescue Service, Qld Ambulance Service, Relevant Local Council and the Queensland Taxi 2. Service shall be advised of all road closures;
- The applicant shall advise in writing, all owners / occupiers of businesses and residences located along roads 3. which will be closed, either partially or fully, of the road closure/s;
- 4. The applicant shall advertise all road closures and traffic deviations in a relevant major newspaper, covering the region the works will be conducted in, at least two days prior to the commencement date;
- Full barricading affixed with 'Road Closed' signs (as designated under the QLD Guide to Temporary Traffic 5. Management (QGTTM)) shall be erected at all closed intersections and the applicant shall be responsible for any fees incurred:
- Police or accredited traffic control officers shall be deployed at all intersections along the closed roads and the 6. applicant shall be responsible for any fees incurred;
- This permit may be cancelled, or the conditions altered by a police officer for the safe and effective regulation of 7. traffic, or the safety of the general public and participants;
- All roads shall be re-opened at the nominated times. All care to be taken to avoid incidents and upon cessation, 8. all signs and material to be removed from roadway and roadway left in good condition and all litter shall be removed and the road returned to its original condition;
- A copy of this permit (and all associated permits/TGS) shall be held on site by the applicant or nominated 9. representative and shall be produced to police if required;

- The issue of this permit does not exempt the applicant from obtaining any relevant permit or authority required by 10. another authority, occupier or owner, e.g. TRC, LVRC, SDRC, and/or DTMR, private property owner, lease holder etc.;
- A copy of this permit (and all associated permits/TGS) shall be held on site by the applicant or nominated 11. representative and shall be produced to police if required;
- 12. The Transport Operations (Road Use Management) Act and Regulations is to be complied with;
- 13. The applicant is responsible to ensure that any barriers, signs, materials or objects of any nature associated with the Site Works comply with the (QGTTM) and during the hours of darkness, barricading shall be positioned around the road closure with sufficient flashing amber lights at regular intervals to give adequate warning to pedestrian and vehicular traffic to prevent collision with barricading;
- This permit only authorises traffic controllers supplied and/or arranged by Energex, Ergon, Energy QLD to 14. provide control of traffic flow for the period of this permit;
- 15. Work is able to be carried out at any time subject to approval and conditions from either TRC, LVRC, SDRC and/or DTMR. No work is to be carried out on public holidays without consent of the relevant local government authority TRC, LVRC SDRC and/or DTMR unless it is Emergency works;
- Business / residents within the closed roads shall be given ingress and egress to and from their premises AT ALL 16. TIMES;
- This permit shall remain in force for the below period unless sooner suspended, surrendered or cancelled; 17.
- This permit is not authorised unless it is signed by all 5 signatories indicated below; 18.
- Any Police Officers required for Special Duty in relation to this permit are to be organised through 19. Permits.SpecialsToowoomba@police.gld.gov.au quoting the above Permit Number;
- The Queensland Police Service will not be responsible for any public litigation that may result from any 20. incidents associated with the accuracy and implementation of the traffic guidance schemes under this permit. The Applicant in signing this notice, accepts all responsibility for any public litigation associated with all Traffic Guidance Schemes and must take appropriate measures to insure they have sufficient legal cover and public liability insurance.
