“One hour prior to commencement of works Traffic Control Room is to be notified of ATA number and attendees onsite, and again at completion of works Traffic Control room is to be notified to advise signing out of ATA and all attendees leaving site.”
Urgent Access (Emergency Work) to restore power or to ensure the safety of the community, the Principle Applicant may access the road network.

"Accepted with the following comments:

All Access to Transurban Assets must adhere to the General Conditions of ATA Permit – issued to applicant upon application of ATA, including the following:

- General Conditions - You must call the relevant TCC, where possible, one hour prior to entry and advise your ATA (TAP) permit number, workers on site and expected duration on site, again upon leaving Transurban Site you must call the TCR advise works completed and all workers leaving
- You must carry your ATA (TAP) permit when on Transurban Sites, ready for inspection by Transurban Authorised Person if requested
- You must download your digital Transurban Permitted Access Card, via the Permitted App (App Store or Google Play) whilst on Transurban sites for inspection by Transurban Authorised Persons if requested
- Notify the Transurban Queensland Traffic Control Centre immediately of any identified or suspected unauthorised access. The TCR should also be advised of any unauthorized waste material including items such as syringes found on site.
- No commercial advertising is permitted at any time including on boundary or temporary fencing.
