4. All traffic control signage is to be as per TGS # 2024-ALT-GENER CS-207 dated 14/06/2024.
5. All traffic control duties to be undertaken by accredited Traffic Controllers or police officers as required as per supplied TGS # 2024-ALT-GENER CS-207 dated 14/06/2024.
6. All traffic control devices are to comply with the Queensland Manual of Uniform Traffic Devices (MUTCD)
7. This permit may be cancelled or the conditions altered by a police officer for the safe and effective regulation of traffic, or the safety of the general public.
8. A copy of this permit shall be held by the applicant or nominated person and shall be produced to police if required.

This permit does not exempt the holder thereof from obtaining any Permit or other authority under and/or otherwise complying with the provisions of any other law.
