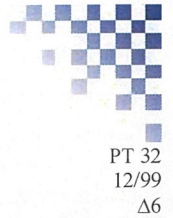

Regulated (or cause to be regulated) traffic including the implementation of stop and hold protocols as required to facilitate minor works and maintenance activities in the Noosa Local Council Area.

Permit shall remain in force from 01/07/2026 to 30/06/2027, unless sooner suspended, surrendered or cancelled.

CONDITIONS

1. On condition of obtaining the relevant Road Reserve Maintenance Activities Approval from the Noosa Local Council and this is to be considered the primary operational document.
2. Adhere to all conditions stipulated in any permit, approvals or authorisations issued by the Noosa Local Council.
3. The closure in only valid between the nominated dates 01/07/26 - 30/06/27 between the hours of 0:00am - 0:00pm
4. All traffic control signage is to be as per TGS # 2024-ALT-GENERIC-207; 2024-ALT-GENERIC-103; 24-QLD-GEN440; 2024-ALT-GENERIC-223; 2024-ALT-GENERIC-135; 2024-ALT-GENERIC-435; 2024-ALT-GENERIC-009 dated 14/06/2024
5. All traffic control duties to be undertaken by accredited Traffic Controllers or Police Officers as required as per the supplied TGS # 2024-ALT-GEN CS-207; 2024-ALT-GENERIC-103; 24-QLD-GEN440; 2024-ALT-GENERIC-223; 2024-ALT-GENERIC-135; 2024-ALT-GENERIC-435; 2024-ALT-GENERIC-009 dated 14/06/2024.
6. All traffic control devices are to comply with the Queensland Manual of Uniform Traffic Devices (MUTCD)
7. The permit may be cancelled or the conditions altered by a police officer if required for the safe and effective regulation of traffic or for the safety of the public or participants.
8. A copy of this permit shall be held by the applicant or nominated person and shall be produced to police if required.

This permit does not exempt the holder thereof from obtaining any Permit or other authority under and/or otherwise complying with the provisions of any other law.
