- 2. Official Traffic Signs - i.e. "Roadworks Ahead", "Half Road Closed", "Prepare to Stop" to be positioned at the approaches to the work area.**
- 3. Witches hats to be positioned around the work area.**
- 4. Delineator line of witches hats to be positioned so as to divert traffic into one correct section of the roadway as necessary**
- 5. All signs, lights and safety cones to be positioned and erected as per the Queensland Transport roadwork signing guide.**
- 6. All signs, lights and safety cones shall comply with the Manual of Uniform Traffic Control Devices - Part 3.**
- 7. Applicant to ensure that all conditions stipulated by the Scenic Rim Regional Council - RCU22/0156 shall be strictly adhered to.**

8. All signs and other materials to be removed from the roadway and road left in good order and serviceable condition.
9. All precautions to be taken to avoid incidents.
10. Authorised traffic controllers to be utilised to control the flow of traffic passing through work construction area.
11. This permit may be cancelled at any time by any Police Officer.
12. This permit is to be held on site and produced upon demand by any Police Officer.

This permit does not exempt the holder thereof from obtaining any Permit or other authority under and/or otherwise complying with the provisions of any other law.
