This access is to facilitate corrective maintenance, repairs as required to Energex infrastructure only, where Energex works may impact power supply to Transurban Assets – Energex will advise Transurban of any operational impacts.
All in lane activities must be in accordance with relevant approvals from Transurban.
“One hour prior to commencement of works Traffic Control Room is to be notified of ATA number and attendees onsite, and again at completion of works Traffic Control room is to be notified to advise signing out of ATA and all attendees leaving site.”
Urgent Access (Emergency Work) to restore power or to ensure the safety of the community, the Principle Applicant may access the road network.
